Every academic year, the chairman of the timetable committee and the CEO prepare the schedule for internal evaluation on the basis of the Academic Calendar. The university circulars and notices are displayed on the notice boards and what's app group of the college. The college finds advanced and slow learners from firstyear undergraduate classes. The entrance test syllabus for first-year undergraduate is up to the intermediate level. After conducting a general entrance test, advanced and slow learners are identified based on their performance in the entrance examination. The schedule of the examination details is available on the college noticeboard. For the first-year courses and programs, the Central Assessment Program (CAP) is undertaken as per the rules and regulations of S.P. Pune University, Pune. The internal examination committee monitors and conducts internal examinations within the college. All the teachers of the concerned departments submit a set of question papers to the examination committee through the Head of the Department. The college conducts class tests, tutorials, unit tests, departmental seminars, and reviews of project works, practical examinations, home assignments, openbook tests and other forms of Continuous Internal Evaluation (CIE).
