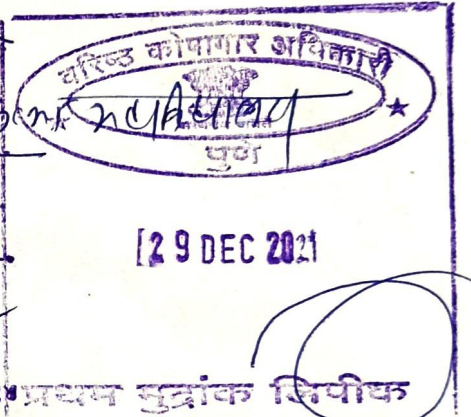

Are herewith making co-operative educational agreement as,


1. The Agreement is valid from academic year 2021-22 to 2025-26
