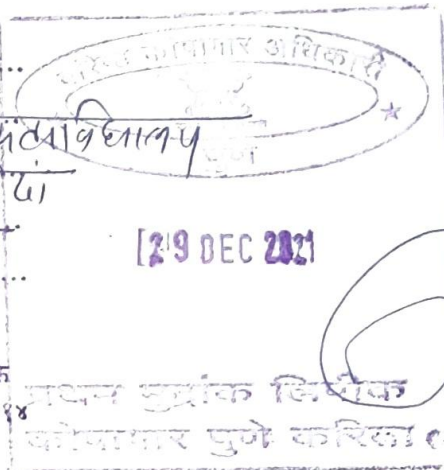

Memorandum of Understanding (MoU)

ARTICLE I: BACKGROUND

This memorandum of understanding is hereby signed between **Bhaktivedanta Research Center, Pune** (Referred as **BRC-Pune**) a charitable trust having Registered under West Bengal Public Trust Act, 1962 vide Regn.no.190303676/2017-18 with **registered office** at 110A, Motilal Nehru Road, Kolkata 700029, West Bengal, India and **Branch office** at Survey No. 50, Katraj Kondhwa road, Pune represented by Dr. Janardan Chitode (Dean Academics) of its Pune Branch.

The Bhaktivedanta Research Center, Pune is established at the premises of New Vedic Cultural Center (NVCC) Pune for preserving, researching and disseminating the rich history, philosophy and cultural heritage of India. BRC will provide training, guiding, academic and research expertise/ platform to various sections of the society such as universities, academic institutes, researchers, students and interested individuals. BRC is globally connected with many international academicians and research scholars of prestigious universities. It has taken many research projects on ancient Indian history, culture and vedic wisdom. BRC is well equipped with libraries, manuscripts, journals and state of the art training facilities.

AND

Kukadi Education Society's Savitribai College of Arts is a college functioning in rural areas of Pimpalgaon Pisa, since June 1999. In this area higher education facilities were not available and students have to travel to nearby colleges located far away. Looking at the need of the students, **Shri. Kundalikrao Ramrao Jagtap Patil**, founder of Karmayogi Kundalikrao Ramrao Jagtap Patil Sahakari Sakhar Karkhana Ltd, Pimpalgaon Pisa, established this college.

College runs the degree programs in arts, science and commerce under SPPU, Pune. It has also post graduate program in arts faculty. More than 500 students from rural area are taking the education in this college. Students of this college have specially rewarded at national level in wrestling. College has played significant roles in social initiatives through its NSS wing especially for getting award to Nimbavi village (adopted village by the college) under Saint Gadagebaba Gram Svachhata Abhiyan of state government. Before the opening of this college, girls in the nearby rural areas were deprived of higher education. This college provided all the facilities for their education and empowerment.



This MoU will be w.e.f. **10 January, 2022** and will be for a period of **60 months** from the date of agreement i.e., till **9 January 2027** & could be renewed further after **5 years**.

As per this MoU various activities such as training courses, seminars, workshop and conferences will be conducted to provide value-based education to students, develop their life skills, teach them practical methods of controlling their negative behavioral patterns, self-management, leadership development. Under this MoU efforts will also be taken to improve spiritual intelligence, emotional fitness, green skills and protection of environment and mother earth. Upliftment of tribal communities, downtrodden societies and weaker sections of the society will also be given special attention.

SCA enters into this Linkage/Collaboration with BRC, Pune with the following mutual understanding and co-operative roles:

ARTICLE II: SCOPE OF THE COLLABORATION

Role of Savitribai College of Arts in this MoU

1. SCA will provide all the necessary facilities.
2. SCA will organize different activities for their staff and students planned under the MoU.
3. SCA will empower its National Service Scheme (NSS) to promote, propagate organize and conduct various social welfare initiatives and drives jointly planned with BRC Pune.
4. SCA will provide library facilities and staff necessary for various courses to be conducted under this MoU.

Role of BRC-Pune in this MoU

1. BRC-Pune will support in identifying the courses and framing the syllabi at SAC for imparting the value-based education.
2. BRC-Pune will train the faculty for conducting various courses designed under this MoU.
3. BRC-Pune will extend its expertise at SCA for enriching library and similar other facilities.
4. BRC-Pune will contribute its knowledge based in the field of value education for publications of SCA.
5. BRC-Pune will provide infrastructure and training facilities available at Pune.

Apart from the above both parties agree to extend support to each other to make this initiative a success. Agreed by both parties.

ARTICLE III: THE AGREEMENT

- At Savitribai College of Arts, Pimpalgaon Pisa, this MoU will be administered by Dr. Shivaji Dhage, Principal, and at BRC-Pune, this MoU will be administered by Dr. Janardan Chitode, Dean Academics, BRC-Pune.
- This MoU may also involve parties by mutual consent, which may be added later by written addendum to this MoU.
- The parties may enter in to specific written agreements under authority of this MoU to clarify and define the nature, extent and terms of operation for the proposed collaborations, including intellectual property ownership and funding issues.

ARTICLE IV: GENERAL TERMS

1. This MoU is not intended to and does not create any right, benefit or trust, responsibility, substantive or procedural, enforceable at law or equity, by either party, its officers, employees, or agents against the other party, its officers, employees, or agents.
2. Nothing in this MoU obligates either party to commit or transfer any funds, assets, or other resources in support of projects or activities between the parties unless expressly stated in this agreement.
3. Both parties are entitled to jointly claim the credits of seminars, courses, research papers, conferences and any other publications as the outcome of various activities planned under this MoU.
4. The activities of this MoU must be carried out in accordance with appropriate laws and regulations existing in the India.
5. If any funding is received by external agencies for supporting the activities planned under this MoU, it should be jointly utilized with mutual consent as per the requirement. Revenue collected from any type of activity under this MoU will be shared by both the parties depending upon the resources involved.
6. Dispute resolution: Any and all disagreement/differences/disputes arising hereunder shall be resolved amicably by the designated officers of both parties empowered by Principal / Director of both the parties.
